- Min 42/10 Serhienko moved that the minutes of the February regular meeting as amended and the March 4<sup>th</sup> special meeting be approved.

- Fin stat 43/10 King moved that the statement of financial activities be approved as submitted.

- Spraying 44/10 Strelieff move that we contact Precision Spraying to get information on ditch spraying

- Operator cert 45/10 Strelieff moved that we use the Town Maintenance foreman to do the operator certification for the R.M. employees.
